

## **NORTH GEORGIA VETERANS HELPING VETERANS**

In 2024, the North Georgia Veterans applied to the Georgia Secretary of State and the IRS to create a new Georgia 501(c)(3) organization, North Georgia Veterans Helping Veterans, Ltd. (NGVHV). This IRS approved entity is used to receive tax advantaged donations that are distributed to help local veterans in need. We use the services of local organizations, including the Jasper Veterans Administration Office, CARES (Community Assistance Resources & Emergency Services), Good Samaritan Health & Wellness Center and St. Vincent de Paul to identify and legitimize requests for funds to help veterans and their families. Donations to this fund in lieu of flowers at Memorial Services and Funerals are particularly appropriate and greatly appreciated, but gifts can be given at any time. Donations qualify for tax deductions.

Checks should be made payable to “North Georgia Veterans Helping Veterans” and mailed to the following address: NG Veterans Helping Veterans, 10912 Big Canoe, Big Canoe, GA 30143. Since NGVHV is a 501(c)(3) charitable organization, Qualified Charitable Donations (QCD's) can be made at any time from your IRA, Donor Advised Funds, or Charitable Gift Accounts (e.g., Family Charitable Funds). This can be a tax-free way to help meet your annual Required Minimum Distribution (RMD) while helping local needy veterans and their families.
